#### REPORTING A CLAIM

[Claim Kit – Your Guide to Reporting an Injury](#) contains a quick reference guide, claim forms, and the brochure you must provide to your employees when an injury or illness occurs.

[File a Claim](#) provides step-by-step instructions on how to file a claim with State Fund.

[Workers' Compensation Claim Form –DWC 1](#) must be provided to your injured worker within one working day of your knowledge of the injury or illness.

[Employer's Report of Occupational Injury or Illness 3067](#) must be submitted no later than five days after the injury or illness occurs or is known.

[Cal/OSHA Reporting](#) is where you find the contact information for Cal/OSHA's Enforcement Unit to report immediately any serious employee injury or death.
